In the interest of administration and for smooth functioning of DLSAs/ TLSCs, the following transfers and postings are ordered with immediate effect;-


1. Sh. Mushtaq Ahmad Bhat, Sr. Assistant DLSA Pulwama is transferred to newly created TLSC Awantipora.
