Subject: National Lok Adalat to be held on 08.12-2018.

Sir/Madam,

Apropos to the initiatives taken by Hon'ble Executive Chairman, NALSA/SLSA to curtail delays and to bring down the pendency.

The next National Lok Adalat in the series shall be held on 08-12-2018 on all subject matters. In this behalf NALSA has directed that wide publicity of National Lok Adalat, including advertisement in Newspapers, be given.

The preparatory work to hold the National Lok Adalat must begin immediately to have a successful Lok Adalat in a much bigger way.

The following types of cases (pre-litigation and pending) can be taken up for settlement in the aforesaid National Lok Adalat.

#### **Pre-Litigation**

- (i) NI Act cases under Section 138;
- (ii) Bank Recovery cases;
- (iii) Labour Disputes cases;
- (iv) Electricity and Water Bills (excluding non-compoundable)
- (v) Other (Criminal Compoundable, Matrimonial and other Civil disputes)

## <u>Pending in the Courts (Which are reflected on National Judicial Data Grid)</u>

- (i) Criminal Compoundable Offences
- (ii) NI Act cases under Section 138;
- (iii) Bank Recovery cases;

- (iv) MACT cases
- (V) Labour disputes cases
- (vi) Electricity and Water Bills (excluding non-compoundable)
- (vii) Matrimonial disputes.
- (viii) Land Acquisition cases.
- (ix) Services matters relating to pay and allowances and Retrial benefits.
- (X) Revenue cases (Pending in District Courts and High Courts
  Only)
- (Xi) Other civil cases(rent,easmetary rights, injunction suits, Specific performance suits) etc.
- 4. In this back drop, I am desired to request you to commence the exercise for identification of the cases category wise to be taken in National Lok and to start holding of regular pre Lok Adalat sessions once in a week for making the National Lok Adalat a big success. In this regard all the Presiding Officers shall identify the maximum number of pending cases and in any case not less than twenty five besides, other cases. Three of the Presiding Officers having contributed highest number of cases would receive commendation letters.

You are also requested to furnish the list of cases so identified and fixed to this authority on 25.11.2018 positively for perusal by the Hon'ble Executive Chairman J&K SLSA and onward submission to NALSA.

The matter may be treated as most urgent.
