2. The Authority/ Committee /HCLSC shall submit monthly drawal & expenditure statement by 5<sup>th</sup> of succeeding month regularly.
3. The Authority/ Committee /HCLSC shall furnish the detailed utilization certificate.
4. Before incurring expenditure, the Authority/ Committee /HCLSC shall comply with all provisions & other circulars/ instructions issued from time to time.
5. The drawing officer shall ensure that the budget allocation of funds shall not exceed in any case.
6. It is further impressed upon that minimum 80% of the balance of funds available with your Authority/Committee may be utilized by 31<sup>st</sup> of March 2019.
